IN RAMSEY COUNTY, THE ALLIANCE AND PARTNERS CONTINUED TO ASK FOR THE INCLUSION OF AFFORDABLE HOUSING AT THE TWIN CITIES ARMY AMMUNITION PLANT SITE IN THE CITY OF ARDEN HILLS. THE CURRENT PLAN FOR THIS DEVELOPMENT, NOW CALLED THE RICE CREEK COMMONS, DOES NOT PROVIDE FOR TRULY AFFORDABLE UNITS, AND WOULD BE BUILT AT AN EXCEPTIONALLY LOW DENSITY LEVEL. ADVOCATES PRESSED THE CITY ABOUT THIS DEFICIENCY IN THE FALL OF 2018, WINNING OVER RAMSEY COUNTY OFFICIALS - THE COUNTY HAPPENS TO BE THE OWNER OF THE LAND AT THAT SITE. NOW THE COUNTY IS CALLING FOR GREATER RESIDENTIAL DENSITIES, AND HOUSING AFFORDABLE AT 30% AND 50% OF THE AMI.
