Capacity Building: In 2020, our field-building work continues to include our Actualizing Equity event series and resource rich e-newsletter, The Link. Together these resources built connections across issues, culture, and geography to strengthen and deepen our collective work for regional equity in the Twin Cities. Additionally, in response to the pandemic and challenges facing our BIPOC small businesses' ability to survive and thrive, we built the Business Resource Collective. The Alliance convened this group of more than 20 culturally- and/or geographically-based community development organizations working in Hennepin and Ramsey County to support BIPOC small business relief, recovery and resilience through COVID-19 and the uprisings. Our goal is to prevent displacement of our businesses, define what a new era for BIPOC small businesses looks like, and secure the resources small businesses will need to thrive. This coalition provides significant constructive feedback to state and county staff as relief policies are being developed and implemented, ground-truthing the public sector's decision-making in the lived experience of BIPOC small businesses, micro-businesses, and entrepreneurs not only survived but are powerfully positioned to thrive and to continue calls for recovery, healing and justice.

coalitions to secure new commitments at high-priority sites and we lead efforts to advocate with renters of color for improved tenant screening practices, inclusionary zoning, rent stabilization, eviction prevention, and other housing policy reforms. The Alliance also supports coalitions of community groups with a stake in how development happens in our communities. We play a pivotal role in surfacing community benefits, convening community groups to organize for desired outcomes, and ensuring we maximize opportunities for affordable housing and economic inclusion. Highlights from 2020 include:

oHousing Equity Now St. Paul: The Alliance co-convened Housing Equity Now St. Paul (HENS), which is advancing housing equity through grassroots campaigns and policy advocacy focused on tenant protections and rent stabilization. In 2020 HENS united as a coalition of community-based organizations that center and elevate the voices of those most impacted by economic and housing injustice to successfully ensure that St. Paul adopted the strongest tenant protections yet in Minnesota.

oHousing Justice League: The Alliance participates in this Minneapolis coalition where collectively we amplified the voice of tenants in the shaping and implementation of tenant protection policies and provided support to Tenant Opportunity to Purchase and Rent Stabilization studies.

oEquitable Development Principles & Scorecard: The Alliance and partners created and advocate for adoption of the Equitable Development Principles & Scorecard, which is a concrete tool multi-sector networks are using to ensure that the principles and practices of economic justice, livability,

equity and affordability are available to all residents. We play a pivotal role in surfacing community benefits in large-scale redevelopments, convening community-based groups to organize for desired outcomes in their neighborhoods, and ensuring we maximize opportunities for transit access and economic inclusion along transitways. We co-developed and train communities and public agencies in using the Equitable Development Principles & Scorecard to advance these goals.

Equity in Place: The Alliance has convened the Equity in Place coalition for years, ensuring that BIPOC communities are at the center of the regional conversation on gentrification and displacement. We bring public sector and community-based partners together around the understanding that people should be able to stay in their communities and thrive, and that new development must reflect the needs and desires of residents. Our goals are to ensure that BIPOC people can meaningfully impact important regional discussions, and that residents have an avenue to participate in discussions about the future of their communities. In 2020 our priorities included:

oStatewide Evictions Moratorium: Understanding clearly the connections between institutional racism and public health and our economy and housing markets, we were a voice calling for a statewide eviction moratorium from very early in the COVID-19 crisis. Throughout the pandemic we successfully worked to keep this moratorium in place and to strongly limit the number of exceptions to it. We continue to be at the table with the administration and MN Housing to extend the current statewide evictions moratorium until
